## "Why Bible Camp?": Thoughts from one who works with youth

The following article is reprinted, with permission, from the April 15 issue of the Richfield Lutheran Church Good News.



June is Luther Park Bible Camp Month at Richfield Lutheran, and I am often asked this question about what is Bible Camp and why is it important. In a world that is filled with everything from "Art Camp to Zoology Camp" and lots of sports and creative camps in between, the concept of Bible camp has gotten buried in a large pile of possible registration forms. But here's the thing....Bible camp is a unique experience, and Luther Park is premiere in that concept.

Camp provides staff trained in leadership, but more importantly, mentoring and a wonderful listening ear for all those conversations that come with teenage angst or elementary-school friendship groups. And they fill the camp with this concept: no child is ever denied the camp experience. A truly servant heart concept in a world where camps of any kind cost around \$500 per week.

Bible Camp also provides a wonderful routine that many children need during the summer. A routine that starts early and goes all day—with a little FOB (Flop On Bunk) time built in.

And talk about faith life developments! They start with morning Word and prayers before all meals, have morning and evening worship with lots of group singing, share in daily Bible themes, devotional small-group discussions AND round it out with LIFE Groups—where kids apply their faith in everyday life. And it all happens in a northwoods setting where children see God's nature all around them, not just as in a zoo.

In a world that has become 24/7, Luther Park also provides a unique challenge for our children. No MP3 players or iPods allowed. No cell phones permitted during camp. Only faith, fun and fellowship for a weekend, a snoop (half week), a full week or a double week. For many of us it's the experience that provides a breath of fresh air (literally) in the busy world we call life.

Why Bible camp? I can't think of a better place to nurture faith for all of us!



#### The 2009 Annual Report of Luther Park to Member Churches Blessings to you as we begin our 51st season of outdoor Christian ministry!

In October of 2008, Luther Park's Executive Committee reviewed outstanding bills, projected expenses, and income sources. The shortfall was serious, and there were no funds from which to draw. Our board of directors sent a letter to our congregations and individuals inviting support and advice regarding the future of Luther Park. Should Luther Park continue to exist? Is there still a need for what the camp offers?

The response was a resounding "Yes!" We entered 2009, the 50th anniversary of our ministry, with a wellspring of support.

- \* Tons of former staff members came back for reunions, and hundreds of people attended special events during the year, including the 50th anniversary celebration in July
- \* Donors and congregations provided 50th anniversary gifts throughout the year.
- \* Volunteers, as part of the "Fit for the Next 50" renovation project, reroofed the program director's house, painted cabins, began renovation of Fir Cabin, removed the old staff house, painted and reroofed two buildings at the top of the hill, and added finishing touches to the Welcome Center. Our plan is to renovate all buildings on site, upgrading energy efficiency and improving aesthetics.

- \* Luther Park was able to sell a small acreage—a property across from the main site—for \$250,000 (\$50,000 was used to pay down the line of credit; \$50,000 was set aside to be used as matching funds for gifts received for the "Fit for the Next 50" renovation projects.)
- \* Bethel Lutheran's gift of \$200,000 (announced in previous years) arrived at Luther Park and is safely invested in the Mission Investment Fund, earmarked for the New Retreat Center as a naming gift, at their request.

As planned, Luther Park made reductions in budget totaling about \$100,000. This included downsizing staff and reducing remaining staff positions to a part-time status for much of 2009. We reduced operating expenses in a number of ways including fewer newsletters and mailings, decreasing the number of weeks of summer camp, increased use of the internet, and in-house printing of publications.

The result of all of this? Your camp will continue to be the number-one place where youth remain active long after confirmation. Bible camp will continue to be a reason people in their 20s and 30s remain active in their faith life. Dynamic college-age counselors will continue to ignite the faith of children and youth!

At our 50th anniversary of Luther Park's ministry, the stories poured in...stories about lives changed, youth connected, pastors called, lay people serving, counselors married, babies baptized, corporate churches enjoying fellowship and communion together in the body of Christ.

Please consider how you might invest in this important ministry of your congregation. We continue to need your prayers, as well as gifts of time and financial help in 2010.







he Luther Park Corporation held its Annual Meeting Sunday, March 14, 2010, at Zion Lutheran Church in Minneapolis, Minn.

Board President Wade Wacholz called the meeting to order and welcomed everyone, leading the group in reading the Luther Park Mission Statement. Devotions were given by Pastor Mark Schmid, which included a review of his background with outdoor ministry in Montana and highlights of Zion's Recovery Ministry. The March 15, 2009, Annual Meeting minutes were reviewed and approved as presented.

Executive Director Joel Legred welcomed and thanked everyone for attending and presented the video from June 2009, "Love to Serve," featuring campers at Luther Park. FINANCIAL REPORT & PROPOSED ANNUAL **BUDGET**

# Planned gifts help sustain a Bible camp's ministry

Editor's note: The following article is reprinted, with permission, from the March, 2010, issue of the Metro Lutheran Newspaper.

n a 180-acre pine forest on Lake 26, Luther Park Bible Camp in Danbury, Wisconsin, has experienced financial challenges like other camps around the country. They are grateful to have support from 40-plus ELCA congregations (in the Twin Cities, northern Minnesota, and northwest Wisconsin) that own and operate the camp, as well as from individual supporters who have made special provisions for the camp's future.

Several planned gifts have been essential in sustaining the camp's ministry. Several years ago, Jessie Bonn left a financial gift for Luther Park through her will because she wanted "every child to attend Bible Camp." Luther Park's board of directors has established a policy that no one is prevented from attending camp simply because of limited financial

Another planned gift was received from Bethel Lutheran Church in north Minneapolis when the congregation decided to close its doors. (Bethel was one of 17 congregations to found Luther Park in 1959.) This naming gift of \$200,000 will help fund a new retreat center allowing the congregation to continue its ministry through Luther Park.

A few years before, Luther Park received a gift of real estate — a large donated house which they have refurbished. The house, now referred to as the Welcome Center, serves as new staff offices, conference center, and yeararound retreat space.

Many gifts have been received that have helped sustain the camp's ministry: gifts of cash and stock, gifts of life insurance, gifts from IRAs, gifts of time and talents, and giftsin-kind, like used vehicles and brand-new

Supporters enjoy the camp because it continues to be one of the few places where youth remain active after confirmation. Bible camp is one of the reasons people in their 20s and 30s remain active in their faith life, according to Joel Legred, Luther Park's executive director. Dynamic college-age counselors ignite the faith of children and youth and are inspired in their own faith.

Legred continues: "At the 50th anniversary of Luther Park's ministry, the stories poured in...stories about lives changed, youth connected, pastors called, lay people serving, counselors married, babies baptized, and corporate churches enjoying fellowship and communication together in the body of Christ. Camp works because it's a relational ministry. Camp continues because generous donors believe it's worth their investment."

Luther Park's involvement of inner-city, suburban and rural congregations as partners in ministry is somewhat unique. Most of the churches that started the Bible camp ministry in 1959 are still members of the corporation. Luther Park also has wonderful cultural and ethnic diversity in the community of people who attend the camp each summer and throughout the year.

- Register Early! Some weeks and programs fill quickly.
- Select a program based on the grade your camper will complete in June 2010.
- Completely fill out the Registration and Health History Form for each camper. Luther Park requests that the health form shown on this page be filled out each year. Parent or guardian and camper signatures must be on the form. The state of Wisconsin requires a physical exam be completed less than 36 months prior to arrival at camp. However, proof of a physical exam is required only if the camper is under the care of a physician for a medical concern, and it must then be signed by the examining physician and received at camp two weeks prior to the camper's arrival.
- Send the Registration and Health History Form with a \$200 deposit to Luther Park. The deposit is not refundable and non-transferable after May 1.
- Final payment is due at the camp office two weeks prior to arrival at camp.
- Upon receipt of registration materials, confirmation, directions to camp, and notice of balance due along with other important information will be e-mailed to you, unless you direct otherwise.
- Registration is on a first-come basis.

The following will not be allowed: racist comments, teasing, fighting, threats, swearing, and any other behavior that is demeaning to another person. We want a positive week for all who attend camp.
- 2. Safety is our number one concern at all times. Obeying all waterfront rules when: swimming, boating, canoeing and fishing allows everyone to have fun in the sun. Waterfront activities are available only when waterfront staff is on duty.
- 3. Campers must be accompanied by a Luther Park staff person whenever outside of camp property.
- 4. We are pleased to offer an alcohol-free, smoke-free and substance abuse-free environment. Exceptions must be approved by the director.
- 5. Luther Park is a weapon-free environment. Campers may not bring any kind of weapon or explosive device, including firecrackers to camp. Use of any object as a weapon to hurt a person, animal or property will not be tolerated.
- 6. Luther Park reserves the right to store camper's personal items that may be inappropriate to their stay. Items will be returned for the trip home upon permission of the parent(s).
- 7. For your protection, all medications (including non-prescription pain relievers) must be turned in to the camp health supervisor. If you are injured or do not feel well, report at once to your counselor or health supervisor. This is important for your safety and for the good of all campers.
- 8. Every camper is expected to follow the entire camp schedule unless excused by the program director.
- 9. To assure the safety of each camper and to provide the best week possible, campers are expected to follow all Luther Park rules that are presented to them while at camp.


## How to get to Luther Park
